Dear Cotswold Customer:

As you are aware, there is increased public and regulatory awareness surrounding the use and effects of Per- and Polyfluoroalkyl Substances (PFAS) at the federal and state levels. Due to the increasing regulatory landscape, Cotswold and its supply chain partners confirm that none of the products, materials, or processes they supply contains or uses PFAS.

None of the products, materials, or processes we provide to contain or use any of the PFAS in the following categories (a) PFAS on the Toxics Release Inventory (TRI)¹; (b) PFAS included in the Fifth Unregulated Contaminated Rule (UCMR 5)²; and (c) any of the PFAS included in the following table:
